

Are you thinking of starting at the Foundation level and based in Bangladesh or Pakistan? Start with ACCA's Foundation Diploma and then transfer to the ACCA Qualification.

ACCA is pleased to announce the launch of the new Foundation Diploma which is currently only available to new students, registerered from 9 May 2013 in Bangladesh and Pakistan and this is in response to demand in these countries for this award.

ENTRY QUALIFICATION

No prior qualifications required You don't need to any previous academic qualification to study this qualification. The ability level is broadly equivalent to SSC or HSC or GCSE level.

To achieve Introductory Certificate you will need to register as a student of FD and complete:

Two exams: Recording Financial Transactions (FA1) and Management Information (MA1) plus Foundation in Professionalism.

To achieve Intermediate Certificate you will need to complete:

Two exams: Maintaining Financial Records (FA2) and Managing Costs and Finance (MA2) plus Foundation in Professionalism.

To achieve Diploma in Accounting and Business you will need to complete:

Three exams: Accountant in Business (FAB), Management Accounting (FMA) and Financial Accounting (FFA) plus Foundation in Professionalism.

HOW DIFFICULT IT IS?

The foundation-level qualifications are broadly equivalent to the following:

Introductory Certificate in Financial and Management Accounting	GCSE standard or equivalent
Intermediate Certificate in Financial and Management Accounting	A-level standard or equivalent
Management Accounting Foundation Certificate	A-level standard or equivalent
Diploma in Accounting and Business	First year of a degree programme or equivalent
Foundation Diploma (Pakistan and Bangladesh only)	First year of a degree programme or equivalent
Certified Accounting Technician (CAT) Qualification	First year of a degree programme or equivalent

CAT QUALIFICATION

You can continue your studies onto the CAT qualification and qualify at technician level. Alternatively, you can continue your studies and become a professional-level accountant. Having completed the Diploma, you can transfer to the ACCA qualification, miss out exams F1, F2 and F3 and continue your studies from F4 onwards.

PROGRESSION TO ACCA QUALIFICATIONS

After completing your CAT qualification, you can continue your studies with the ACCA qualification. You will be given exemption from the first three exams of the ACCA qualification (F1, F2 and F3) and your one year's practical experience can count towards the three years of practical experience needed for the ACCA membership. You've made a great start, so why not continue the journey and become a professionally qualified accountant and an ACCA member?

Certificates in Auditing, Taxation and Financial Management are suitable for anyone working or want to specialize in these areas, including school leavers or those who already working in accounts & finance supported roles.

FOUNDATIONS IN PROFESSIONALISM

If you become one of ACCA students and study for any of its entry level qualifications within ACCA Foundation Diploma (FD) & wish to receive a certificate for the level you have completed, you will also need to complete Foundations in Professionalism. ACCA QUALIFICATION

INTRODUCTION

ACCA enables members to attain a premier professional qualification in accountancy and provides graduates with knowledge, skills, values and attitudes to become finance professional in an organization. Graduates with an ACCA qualification are likely to gain employment with relative ease, be it locally or internationally. It also paves the way to many sectors of work including fiancial and corporate sectors.

ENTRY REQUIREMENT

For entry to ACCA's professional examination route, you must be meet at least one of the criteria:

- 1) Graduate / Masters Degree (in any Discipline)
- 2) 2 A Levels (Grades A-E) +3 GCSEs/O'levels (Grades A-C) in 5 separate subjects including English and Mathematics.

PRACTICAL EXPERIENCE REQUIREMENT (PER)

In order to become an ACCA qualified you will need to complete the Practical Experience Requirement (PER) as well as passing your exams and the professional ethics module.

THERE ARE FOUR COMPONENTS TO YOUR PER:

- Completing three years' employment in an accounting or finance related role (s).
- Achieving the Nine Essentials and any four options of the performance objectives to the satisfaction of your workplace mentor.
- Record and report your PER progress through the Trainee Development Matrix (TDM).
- Making a PER return each year.

You can gain your practical experience before, during or after completion of exams. There is no time limit to gain practical experience and applying for ACCA membership. However, the performance objectives are closely linked to the exam syllabus and it is recommended that you co-ordinate your study with the practical achievement.

Be registered with Oxford Brookes University i.e. choose in to the BSc degree scheme before passing any of the three ACCA Fundamentals papers-F7, F8 and F9.

- Pass the three ACCA Fundamentals papers F7, F8 and F9 and pass other papers as required to successfully complete all Nine Fundamentals level papers.
- Hold a recognized english language qualification certificate & transcript (If Applicable), which must be submitted to and approved by ACCA before passing any of papers F7, F8 or F9. For more please visit:

- Complete the ACCA Professional Ethics module by the published deadline before submitting a research and analysis project to Oxford Brookes University.

RAP SUBMISSION DATES

The next two RAP submission periods, and the dates on which RAP grades and BSc degree results will be dispatched, are as follows:

The degree must be completed within 10 years of your initial registration on to ACCA's professional qualification otherwise your eligibility will be withdrawn.

If you are unsure on your eligibility for the Oxford Brookes BSc (Hons) in Applied Accounting degree, you should refer to myACCA which will tell you whether or not you have opted in to the degree scheme and whether or not you are eligible.

FEES

You are required to pay a project submission fee to Oxford Brookes University with any project submission. The Oxford Brookes University RAP submission fee for period 31 is £194. This fee is subject to increase in subsequent submission periods.

It is your responsibility to find someone to act as your Project Mentor and to arrange three meetings with him or her. - Be an ACCA member (ACCA students and affiliates are not eligible).
- Have a minimum of three years' professional/ managerial work experience.
- Two written references (One normally academic)

Oxford Brookes University (MBA) - Entry Dates

The Oxford Brookes Global MBA is a blended programme and you choose how you study. MBA modules can be studied online* or intensively on-campus for one-week periods or a combination of both.The entry points for the Oxford Brookes Global MBA March and September.

You can complete the programme in 30 months. ACCA members can receive credit for certain modules, enabling them to complete the distance learning programme in 21 months.

English language requirements







Assignment Assessment Procedure

The programme team consists of all the staff responsible for the delivery, assessment and verification of a BTEC qualification. It is extremely important that sufficient systems and procedures are in place prior to delivering a BTEC programme. The roles undertaken by the programme team include the following:

Programme Leader

A Programme Leader or Programme Manager is a person designated by a centre to take overall responsibility for the effective delivery and assessment of BTECs in their subject. The Programme Leader may also act as an Assessor and/or Internal Verifier.

Internal Verifier

Internal Verifiers conduct quality checks on assessment processes and practice to ensure that they meet national standards and that all students have been judged fairly and consistently. An Internal Verifier can be anyone involved in the delivery and assessment of the programme that is able to give an expert "second opinion". Where there is a team of Assessors, it is good practice for all Assessors to be involved in internally verifying each other. Please note that as an Internal Verifier you cannot internally verify your own assignments or assessment decisions.

Assessor

An Assessor is anyone responsible for the assessment of students and acts under the guidance of the Programme Manager who will direct Assessors to appropriate training, support and standardisation. Typically, Assessors will devise assignment briefs, deliver the programme of study and assess the evidence produced by students against the assessment criteria in the programme specification.


